The information you provide on this form is subject to the provisions of the Privacy Act (2020). It will remain confidential and be used solely to determine your suitability for EIT student accommodation.

- Prior to arrival at the Student Village, I agree to pay a bond of \$450 and rent of \$2,250 (ten weeks in advance) to confirm my application. The bond is refundable upon vacating subject to villa/ room inspection.

- I agree that one month before the conclusion of me vacating I will confirm my departure date or make arrangements to extend my stay subject to room availability.
