Grow your horticulture career

By the end of the Horticulture Apprenticeship Programme you will have completed the following approved NZQA qualifications:

- NZ Certificate in Horticulture (Fruit Production) (Level 3) 75 credits
- NZ Certificate in Horticulture Production (Fruit Production) (Level 4) 90 credits

Year one - NZ Certificate in Horticulture (Fruit Production) (Level 3)

This qualification will provide you with the skills and knowledge in pest and diseases, pruning, agrichemicals, digital tools, irrigation, soils and team work.

Year two - NZ Certificate in Horticulture Production (Fruit Production) (Level 4)

The NZ Certificate in Horticulture Production (Fruit Production) (Level 4) will be completed in your second year and will cover the implementation and monitoring of fruit crops to achieve production goals and standards through orchard operations, protection and management techniques.

As a graduate of the programme you will be able to pursue a professional career as an Orchard Leading Hand, Foreman, Manager or Future Owner/Operator. In particular, the programme is designed to:

- Raise skill levels of horticultural staff.
- Provide stimulating collegial support for workers in horticulture.
- Offer work-place based training with supported theory study at EIT | Te Pūkenga.
- Provide a pathway for ongoing and further study in horticulture.

Career and study opportunities

On successful completion of the Horticulture Apprenticeship Programme you may choose to continue your studies by enrolling in the:

- NZ Diploma in Horticulture Production (Fruit Production) (Level 5)
- NZ Diploma in Primary Industries Business Management (Level 5)

Industry-based training

You are required to commit yourself to working in the fruit production industry for the duration of the programme.

Courses will be operated from EIT | Te Pūkenga Tairāwhiti campus and orchard properties, with learning being directed by growers, industry experts and qualified EIT | Te Pūkenga staff. You are expected to attend all scheduled classes. In busier times of the year some alternatives may be available for planning around work.


Courses will teach theory that underpins on-job practices in the work environment. Some tasks will be assessed on-the-job as well. On-campus courses and on-the-job learning will complement each other as much as possible.

Timetable

The Horticulture Apprenticeship Programme will suit those that are in full-time work within the horticulture and/or fruit production industry.

Contact time

Classes are usually scheduled between 8.00am-4.00pm and tutorials are scheduled from 4.00pm-7.00pm to suit work requirements.

Entry requirements

Each qualification has its own entry requirements, please talk with the Programme Coordinator regarding these.

You must be committed to being employed within the fruit production industry for the duration of the programme. Those currently employed in a horticulture business, and also those interested in combining this programme with employment in the fruit production industry are invited to apply.

A personal interview may be part of the application process.

English language entry requirements

Applicants are required to have attained an acceptable level of English language fluency. This may be demonstrated in a variety of ways, including successful study in English, approved scores on TOEFL or IELTS (5.0 Academic) tests, completion of accepted international equivalents, or completion of an EIT | Te Pūkenga assessment.

Entry with credit

You may already have some knowledge or skills that can be recognised as part of your intended study. This may take a number of different forms including study while at high school, study at a private training establishment, workplace training, other tertiary study, life experiences or voluntary work. If you think you may qualify, you may want to apply for Cross Credit (CC) or Recognition of Prior Learning (RPL).

- CC is based on the equivalency of courses or qualifications. You would apply for CC if you have passed a very similar course at the same level.
- RPL is based on the assessment of your current knowledge and skills. You would apply for RPL if you had gained the relevant knowledge and skills through life experiences and informal learning situations.

This programme does not have holidays and it is also not semesterised. It does have a break however, during the harvest season. Please confirm with the Programme Coordinator the dates of holidays and exact start and end dates.

You will be asked to provide details of anything that you would like to be considered as credit toward your intended programme of study, as part of your application.

You must apply prior to enrolment. CC and RPL cannot be awarded for a course if you are already enrolled in that course.

How to enrol

There is an easy 3-step process to follow when enrolling at EIT | Te Pūkenga.

Step 1

Check out eit.ac.nz to see the programmes available for you to study. A copy of the course information for each programme is available on our website.

Step 2

You can now use your RealMe verified identity to apply for study at EIT | Te Pūkenga. If you use your RealMe verified identity you will no longer be sent a copy of your application form to sign. You also will not need to provide us with a copy of your primary ID.

If you apply online without using RealMe then you will be sent a summary of your enrolment to check and sign. It will also include course selection forms which you need to complete and return. Your enrolment cannot progress until you have sent the summary and forms back to us.

You can also apply using a paper enrolment form. Please call us on **0800 22 55 348** and we will send you one out.

You will receive an acceptance letter from your Faculty with programme information. This will include the start date of your study and any special information regarding your programme. Depending on your chosen programme of study, you may be invited to attend an interview before you are accepted.

Step 3

Arrangement for full payment of enrolment fees must be made before the start of your programme. You will receive an invoice with payment details.

Fees-free government scheme: Tertiary education is fees-free for eligible domestic tertiary students. To check if you are eligible, go to FeesFree.govt.nz and enter your National Student Number (NSN). If you are not eligible you will be responsible for paying your fees.

Scholarships and grants: Scholarships and grants make life easier by helping to cover your fees, other costs and living expenses while you study. You don't always need to be an academic high-flyer to qualify. You can find out more about scholarships and other options for paying your fees at eit.ac.nz.

StudyLink: If you need to pay for your own study you can choose to apply for your Student Loan and Student Allowance with StudyLink. You should do this early, even if you haven't yet been accepted on your programme. You can change your details later if anything changes. Visit studylink.govt.nz to find out more about StudyLink.

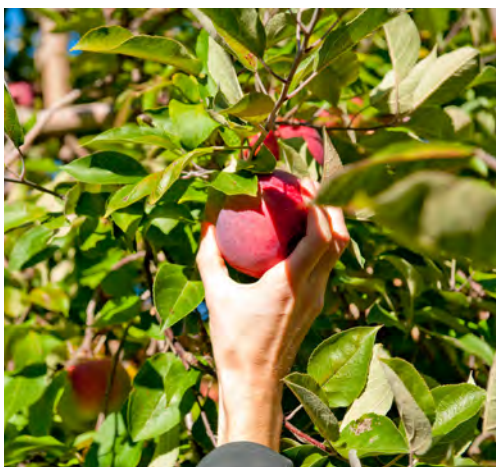
Student services levy
